## STALLHOLDER CONDITIONS

- STALL APPLICATION:** 'The Boardwalk Lifestyle Resort Health Expo' owner, reserves the right to reject any Stall Application it deems inappropriate for 'The Boardwalk Lifestyle Resort Health Expo'
- APPLICATION REJECTION:** If a Stall Application is rejected, Ettalong Beach Tourist Resort will advise in writing and Stall Site & Ancillary Fees will be refunded immediately.
- SITE REFUNDS:** Once a Stall is approved, Stall Site & Ancillary Fees are **not** refundable for any reason
- SET-UP TIME:** All Stallholders, Amusement Operators & Entertainers are to be set-up prior to **8.30AM** on both Saturday & Sunday
- DISMANTLE TIME:** No Stallholder or Amusement Operator is to dismantle their site prior to **4.00PM** on both Saturday & Sunday as this poses a Safety threat to visitors and other stall operators.
- VEHICLES:** Stallholders must **not** bring their vehicles into the venue site at any time other than set-up and dismantle times.
- PARKING:** **No** parking is available on the venue site or near your stall site at any time other than set-up and dismantle times.
- STALL SITE SIZE:** All Sites available measure **3m X 3m** or **6m x 3m** – if an applicant requires a stall site larger than described in the Site Application, then they must advise organisers, pay for a larger site as advised and receive approval from organiser.
- STALL SITE:** Site position will be determined by the Expo organisers. Stallholders must conduct their business within confines of their allocated site and must not move from their allocated site unless given written permission of from the Event owner.
- ELECTRICITY:** **Only** Site Applications that have requested and paid for electricity will be supplied power on the days of the event. Electrical extension cords must be 10metres min length, tagged as safe by an accredited electrician + provided by the Applicant.
- WATER:** **No** running water will be supplied to Stallholders – you must bring your own water in suitable containers.
- GROUND COVERS:** All Food Stalls **must** provide tarpaulins, drip trays or oil mats to provide protection to the ground of venue.
- STALLS:** Covered Stalls supplied are **not** waterproof – it is the stallholder's responsibility to ensure merchandise is protected from weather.
- PRODUCTS:** Any Stallholder selling products that are **not** on their Application or without previous approval by organisers, may be asked to cease trading and evicted from the event.
- GARBAGE:** Any food, liquid waste or rubbish of any description **must** be removed from the site by the Stallholder.
- FOOD ACT 1989:** All Food Stalls **must** comply with the provisions and regulations of the Food Act 1989.
- OCCUPATIONAL HEALTH & SAFETY ACT 2000:** All Stallholders should comply with the regulations of the Occupational Health & Safety Act 2000, to ensure the health and safety of all visitors, suppliers and stallholders to the event.
- DANGEROUS GOODS:** Dangerous or harmful goods including Silly String, toy guns or throw downs are banned from sale at the expo. Any Stallholder not complying with this condition will be removed from the expo.
- WET WEATHER:** The 'Boardwalk Lifestyle Resort' Health Expo **will** proceed regardless of wet or inclement weather – no refunds will be given for inclement weather.
- PUBLIC LIABILITY INSURANCE:** All Stallholders **must** have Public Liability Insurance covering their activities at the Expo, for a minimum of \$10 Million. Insurance **must not** be split between personal and public liability insurance.
- LIABILITY:** Stallholders are liable for any damage to any property owned by Ettalong Beach Tourist Resort, its partners, staff and associates, plus participants and visitors to the Expo.
- AGREEMENT:** Stallholders agree to comply with any reasonable requests by the Ettalong Beach Tourist Resort, organisers, or venue owners, staff, or representatives or other person authorised by the event owner/organisers.
